**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR,  
COUNTY OF OCEAN, STATE OF NEW JERSEY, ACCEPTING  
THE RESIGNATION OF AND AUTHORIZING THE  
COMPENSATION OF ACCUMULATED TIME AS FULL TIME  
TELECOMMUNICATOR AND AUTHORIZING THE  
APPOINTMENT OF BARRY LANCE AS A PER DIEM  
TELECOMMUNICATOR FOR THE LITTLE EGG HARBOR  
TOWNSHIP POLICE DEPARTMENT**

**WHEREAS**, on May 11, 2023, Barry Lance submitted a request for resignation as full-time telecommunicator; and

**WHEREAS**, as of the date of his resignation, Barry Lance will have accumulated 11.25 hours of unused time over the course of his employment with the Township of Little Egg Harbor; and

**WHEREAS**, Barry Lance is entitled to compensation for a total of 11.25 hours for unused vacation time in the amount of \$230.63 less 5.00 hours he utilized of personal time owing the township \$102.50, for a total payment of \$128.13; and

**WHEREAS**, Barry Lance wishes to continue as a per-diem telecommunicator effective May 12, 2023; and

**WHEREAS**, the Township Business Administrator has recommended the appointment of Barry Lance as a per diem telecommunicator; and


**WHEREAS**, the Township Committee wishes to accept the resignation of Barry Lance as a full time telecommunicator and authorize payment for his accrued time in the amount of \$128.13 and to appoint Barry Lance as a per diem telecommunicator.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That the Governing body does hereby accept the resignation of and authorize payment to Barry Lance as full time telecommunicator in the amount of \$128.13 for unused accumulated time.
2. That Barry Lance is appointed as a Per Diem Telecommunicator for the Little Egg Harbor Township Police Department, effective May 12, 2023.
3. That Barry Lance shall be compensated at a rate of \$22.00 per hour for Per Diem Telecommunicator in accordance with the Township Salary Ordinance.
4. That this Resolution shall be effective immediately.
5. That a certified copy of this resolution shall be forwarded to the Chief Financial Officer, Civil Service Commission, the Chief of Police and Barry Lance.
