RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, ACCEPTING THE DONATION OF SIXTEEN (16) PASSENGER BUS FROM NATIONAL EXPRESS CORP. AND AUTHORIZING EXECUTION OF ANY AND ALL DOCUMENTATION TO EFFECTUATE SAME

WHEREAS, National Express Corporation desires to donate a sixteen (16) passenger bus, VIN 1GBHG31V571209916, to the Township for its use; and

WHEREAS, N.J.S.A. 40A:5-29 authorizes any local unit to accept bequests, legacies and gifts made to it and empowers it to utilize such bequests, legacies and gifts in the manner set forth in the conditions of the bequest, legacy or gift, provided, however, that such bequest, legacy or gift shall not be put to any use which is inconsistent with the laws of this State and of the United States; and

WHEREAS, the Township desires to accept the sixteen (16) passenger bus, VIN 1GBHG31V571209916, from National Express Corporation and authorizes execution of any and all documentation to effectuate same.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body accepts the sixteen (16) passenger bus, VIN 1GBHG31V571209916 from National Express Corporation in accordance with N.J.S.A. 40A:5-29.
2. That the governing body further authorizes execution of any and all documentation to effectuate said donation in accordance with the terms of this Resolution.


