ORDINANCE NO. 2023-22

AN ORDINANCE OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 261, ENTITLED "PARKS"

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the

Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

SECTION 1. That the governing body hereby amends Chapter 261, "Parks,"

so as to amend Article I, "General Regulations," so as to amend §261-12 entitled "Swimming"

so as to amend Subsection(C)(4)(g) in its entirety as follows:

§261-12 Swimming

* * *

- **C.** In regard to Parkertown Beach and Mystic Beach, the following regulations shall apply in addition to the regulations set forth above:
 - * * *
 - (4) Take or permit an animal to be upon any beach or in the water adjacent thereto, except as provided in 261-20(A) herein.

SECTION 2. That the governing body hereby amends Chapter 261, "Parks," so

as to amend Article I, "General Regulations," so as to amend §261-20 in its entirety as follows:

§261-20 Animals and pets

- A. It shall be unlawful for any person who has the custody and control of any pet or domesticated animal, including but not limited to dogs and cats, to allow, suffer, permit or abandon said pet or domesticated animal in any Park.
 - 1. Exceptions.
 - a. Leashed dogs and other domesticated animals shall be allowed at Mystic Beach and Parkertown Beach only, from October 1 through May 1, inclusive. Said animals must be securely confined or controlled by an adequate leash no longer than six feet in length. Said animals shall be prohibited at all other times.

- b. Service animals shall be allowed in Parks at any time, but must be leashed and under the control of the owner of said service animal.
- B. It shall be unlawful to ride any horse, mule, donkey or pony in any Park except upon Township-designated paths or trails. Said animal shall be under the control and restraint of its rider at all times

SECTION 3. All ordinances or parts of ordinances inconsistent herewith are

hereby repealed.

SECTION 4. If any section, subsection, sentence, clause, phrase or portion of

this ordinance is for any reason held to be invalid or unconstitutional by a court of competent

jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and

such holding shall not affect the validity of the remaining portions hereof.
