#### TOWNSHIP ENGINEER COMMENTS

Township Engineer, Jason Worth, reported the NJDOT grant applications that were approved at tonight's meeting are due July 1 but he will be submitting the applications tomorrow. He also stated there are several federal grant applications that will be coming out in July and August and applications will be on next month's agenda for the grant funding. He continued by stating the township bulkhead project is underway and the three locations along Twin Lakes Blvd are in construction and one is almost complete after restoration. He continued by stating the county is having a preconstruction meeting next week with the contractor, which he will be in attendance for coordination purposes and will report back all details to the Committee.
