SUPPORTING PROPOSED NORTH JERSEY
TRANSPORATION PLANNING AUTHORITY
(NJTPA)/OCEAN COUNTY SUBREGIONAL STUDIES
PROGRAM FY2025 - FY2026**

WHEREAS, the Ocean County Department of Planning is applying to participate in NJTPA’s FY2025 - FY2026 Subregional Studies Program; and

WHEREAS, if accepted, Ocean County would partner with the NJTPA to conduct a study entitled “Ocean County Coastal Evacuation Plan Improvements Study”; and

WHEREAS, the purpose of the study is to identify improvements and recommendations to ensure effective, safe, and sustainable evacuation routes; and

WHEREAS, the study will commence in the Fall 2024 and conclude no later than June 30, 2025; and

WHEREAS, the support of the Township assists in getting NJTPA approval for the Ocean County application and the Township would participate in a Technical Advisory Committee to review and provide feedback on the draft study reports and findings;

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body supports the participation in the NJTPA’s FY2025-FY2026 Subregional Studies Program and supports the submission of an application by Ocean County to conduct a study entitled “Ocean County Coastal Evacuation Plan Improvements Study.”
2. That the governing body further commits to participate in the Technical Advisory Committee for the above-stated study to provide feedback on
