## RESOLUTION NO. 2023-257

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TAX COLLECTOR TO CANCEL TAXES AND PROVIDE A REFUND PURSUANT TO N.J.S.A. 54:4-3.30 ON PROPERTY QUALIFYING FOR VETERANS PROPERTY TAX EMEMPTION (SOLIMAN, REMON S., BLOCK 325.80, LOT 33)

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from property taxes on certain property owned by a totally-disabled Veteran; and

WHEREAS, it has been determined by the Tax Assessor that property known as Block 325.80, Lot 33, owned by Remon S. Soliman, qualified for a Veterans' Property Tax Exemption in the year 2023; and

WHEREAS, the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and

WHEREAS, the Tax Collector has requested authorization to cancel property taxes, in the amount of \$2,086.50; and

WHEREAS, pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally-disabled veterans portion of the 2023 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and

WHEREAS, the Tax Collector deems that the mortgage company, Corelogic Tax Service, receive a refund on taxes already paid for the year 2023 in the amount of \$388.09; and

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

- 1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes in the amount of \$2,086.50 for the year 2023 for Block 325.80, Lot 33, owned by Remon S. Soliman and authorize a refund to mortgage company, Corelogic Tax Service, in the amount of \$388.09.
- 2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor, Remon S. Soliman, Corelogic Tax Service and the Chief Financial Officer.

## TOTALLY DISABLED VETERAN ASSESSMENT CREDIT WORKSHEET

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from taxes on certain property owned by a totally-disabled veteran; and

WHEREAS, it has been determined by the Tax Assessor that the property known as Block 325.80 Lot 33 owned by Soliman, Remon S qualifies for a Veteran's Property Tax Exemption as of August 22, 2023.

WHEREAS, the determination by the Tax Assessor is the result of an assignment of a one hundred percent permanent and total wartime service-connected disability evaluation from the Veterans Administration; and

WHEREAS, the Tax Collector has requested authorization to cancel property taxes for 2023 based upon a prorated assessment of \$207,400 applied by the F02 Tax Rate, taxes outstanding that would otherwise be exempt.
