RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING PET PARADE/PET COSTUME CONTEST AT LITTLE EGG HARBOR RECREATION COMPLEX DURING ANNUAL HARVEST FESTIVAL

WHEREAS, on October 21, 2023, the 5th Annual Harvest Festival will be held from 11:00 a.m. to 5:00 p.m. at the Little Egg Harbor Recreation Complex; and

WHEREAS, the Little Egg Harbor Chamber of Commerce has submitted the special event permit application and paid the appropriate fees pursuant to Chapter 294 of the Township Code; and

WHEREAS, as part of the 5th Annual Harvest Festival, the applicant requested that it be allowed to conduct a pet parade/pet costume contest during the festival; and

WHEREAS, the Township desires to exempt the pet parade/pet costume contest at the 5th Annual Harvest Festival from the prohibitions within Chapter 261, "Parks", §261-20 "Animals and pets" so as to allow this event to occur at the Little Egg Harbor Recreation Complex on October 21, 2023 from 11:00 a.m. to 5:00 p.m. only; and

WHEREAS, the regulations contained within Chapter 134, "Animals" shall remain in full force and effect, including but not limited to, provisions regarding disposal of pet waste, control of dogs and/or pets and licensing.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body authorizes a one-time exemption from regulations contained in Chapter 261, "Parks", §261-20 "Animals and pets," for the pet parade/pet costume contest at the 5th Annual Harvest Festival at the Little Egg Harbor Recreation Complex on October 21, 2023 from 11:00 a.m. to 5:00 p.m.

2. That all other regulations, particularly Chapter 134, "Animals," shall remain applicable to the event.

3. That a certified copy of this resolution shall be forwarded to the Township Administrator, Chief of Police, Code Enforcement Office and Little Egg Harbor Chamber of Commerce.
