**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG
HARBOR, COUNTY OF OCEAN, STATE OF NEW
JERSEY, AUTHORIZING THE TAX COLLECTOR TO
CANCEL TAXES ON PROPERTY QUALIFYING FOR
PROPERTY TAX EXEMPTION**

WHEREAS, N.J.S.A. 54:4-3.3b provides for an exemption from taxes on certain property owned by the State of New Jersey where real property is acquired by the State or by a State agency, or by an authority created by the State, by purchase, condemnation or otherwise, such property shall become tax exempt on January 1 of the calendar year next following the date of acquisition, provided that the tax assessor of the municipality in which such property is located is given written notice of the acquisition by certified mail on or before January 10 of said calendar year next following; provided further that if real property is acquired between January 1 and January 10 inclusive and the prescribed notice is given on or before January 10, such real property shall become tax exempt as of the date of acquisition; and

WHEREAS, it has been determined by the Tax Assessor that the following properties owned by the State, Department of Environmental Protection, qualified for a Property Tax Exemption in the year 2023, namely,


