RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, REVIEWING THE LITTLE EGG HARBOR BOARD OF FIRE COMMISSIONERS, DISTRICT NO. 3 COMPENSATION IN ACCORDANCE WITH N.J.S.A. 40A:14-88

WHEREAS, N.J.S.A. 40A:14-88 provides that each member of the board of fire commissioners shall receive as compensation such amounts as the board shall fix, subject to review by the governing body wherein the fire district is located; and

WHEREAS, the Little Egg Harbor Township Board of Fire Commissioners, District No. 3, adopted Board Resolution, attached hereto as Schedule A, which fixed the annual compensation of the Commissioners for the year 2024 at \$11,400.00 for the Treasurer and \$6,000 for each of the remaining commissioners; and


WHEREAS, the Township Committee has reviewed the compensation in accordance with N.J.S.A. 40A:14-88.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body has, in accordance with N.J.S.A. 40A:14-88, reviewed the compensation fixed by the Little Egg Harbor Township Board of Fire Commissioners, District No. 3, as provided within Board Resolution, attached hereto as Schedule A, which fixed the annual compensation of the Commissioners for the year 2024 at \$11,400.00 for the Treasurer and \$6,000 for each of the remaining commissioners.
2. That a certified copy of this resolution be forwarded to the Chief Financial Officer and the Little Egg Harbor Township Board of Fire Commissioners, District No. 3.
