**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG
HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY,
APPOINTING JODI TERMI AS INTERIM COURT
ADMINISTRATOR, AND SUBSEQUENTLY COURT
ADMINISTRATOR, PURSUANT TO N.J.S.A. 2B:12-10**

WHEREAS, the Township is in need of a Court Administrator, as the person currently holding the position, Alina Bertram, is retiring on February 1, 2024, thereby creating a vacancy; and

WHEREAS, Alina Bertram is utilizing leave until her retirement date, so an interim appointment to Court Administrator is also required to fulfill the duties of the position until February 1, 2024; and

WHEREAS, Jodi Termi is duly qualified to be appointed to the position of Court Administrator in accordance with N.J.S.A. 2B:12-10 and Administrative Office of the Courts Guidelines; and

WHEREAS, the AOC and the Assignment Judge for the Ocean Vicinage have approved said appointment; and

WHEREAS, the Township desires to appoint Jodi Termi as interim Court Administrator for the Township until February 1, 2024, at which time the appointment to Court Administrator shall become a permanent appointment.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby appoint Jodi Termi as the interim Court Administrator in accordance with N.J.S.A. 2B:12-10 et seq., effective December 27, 2023 and to continue until February 1, 2024.


