**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG  
HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY  
AUTHORIZING RE-ADVERTISEMENT FOR BIDS FOR  
TWO (2) 2023 OR NEWER AUTOCAR (ACX) OR BRAND  
EQUIVALENT SIDE LOADER TRASH TRUCK 31 CY**

**WHEREAS**, Little Egg Harbor Township advertised for bids in accordance with Local Public Contract Law for Two (2) 2023 or newer Autocar (ACX) or Brand Equivalent Side Loader Trash Truck 31 CY, with sealed bids to be opened on December 1, 2023; and

2. That the QPA and/or Administrator are authorized to amend the bid specifications, if necessary.
3. That the QPA is authorized to determine the time, date and place for receipt of bids for Two (2) 2023 or newer Autocar (ACX) or Brand Equivalent Side Loader Trash Truck 31 CY.
4. That the Township Clerk shall forward a certified copy of this Resolution to the QPA and the Administrator/CFO.


