WHEREAS, N.J.S.A. 54:5-1 et seq., the "tax sale law" provides for the creation, enforcement and collection of liens for unpaid taxes and other municipal liens on real property; and

WHEREAS, the intent is only to remove the duplicative 2022 added/omitted from the tax sale for 18 Cobblestone Lane, also known as Block 284.02, Lot 36 on the Township Tax Map, and this removal shall not affect the validity of a tax sale for the property as to other delinquent taxes warranting a tax sale.
