RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, APPOINTING MEMBERS TO THE FLOODPLAIN MANAGEMENT PLAN COMMITTEE

WHEREAS, Chapter 49 of the Township Code of the Township of Little Egg Harbor authorizes a Floodplain Management Plan Committee to assist the Township in preparing a Floodplain Management Plan within the Township; and

WHEREAS, the Township Committee desires to appoint the following ex officio members to the Floodplain Management Plan Committee:

1. Michael Fromosky, representing the Building Department/Code Enforcement, for a term of two years commencing January 1, 2024 and expiring December 31, 2025;
2. Jason Worth, representing Engineering, for a term of two years commencing January 1, 2024 and expiring December 31, 2025;
3. Mark Ellis, representing Land Use Planning/Zoning and Housing and Community Development, for a term of two years commencing January 1, 2024 and expiring December 31, 2025;
4. Brad Griffin, Superintendent of Public Works, representing Public Works/Parks & Recreation, for a term of two years commencing January 1, 2024 and expiring December 31, 2025;
5. Chief James Hawkins, representing Public Safety/Emergency Management for a term of two years commencing January 1, 2024 and expiring December 31, 2025;
6. Rodney Haines, representing Public Information, for a term of two years commencing January 1, 2024 and expiring December 31, 2025;
7. Thomas Bonfonti, representing Environmental Protection/Public Health, for a term of two years commencing January 1, 2024 and expiring December 31, 2025;

8. Township Committeeman John Kehm, representing the Township Committee, for a term of two years commencing January 1, 2024 and expiring December 31, 2025;


WHEREAS, all members of the Floodplain Management Plan Committee shall serve without compensation.
