RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE STATE OF NEW JERSEY, DEPARTMENT OF TRANSPORTATION, REQUESTING \$1,026,330.38 LOCAL TRANSPORTATION PROJECTS FUND 2024 FOR PEDESTRIAN SAFETY IMPROVEMENTS TO RADIO ROAD

WHEREAS, the Township of Little Egg Harbor desires to apply for and obtain 2024 Local Transportation Projects Funding from the State of New Jersey, Department of Transportation (hereinafter "NJDOT") in the amount of \$1,026,330.38 for Pedestrian Safety Improvements to Radio Road; and

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the submission of an electronic application for "LTPF-2024 Pedestrian Safety Improvements to Radio Road - 00051" to NJDOT for \$1,026,330.38 Local Transportation Grant for Pedestrian Safety Improvements to Radio Road.
2. That the Mayor is authorized to execute and the Township Clerk to attest to any and all documentation to complete said application for the grant award and their respective signatures constitutes acceptance of the terms and conditions of the grant agreement and approval of the execution of the grant agreement.
3. That the governing body recognizes and accepts that the NJDOT may offer a lessor or greater grant amount, and therefore, upon receipt of the



grant agreement from the NJDOT, does further authorize the execution of any such grant agreement; and also upon receipt of the fully executed agreement from the NJDOT, does further authorize the expenditure of funds pursuant to the terms of the agreement between the Township of Little Egg Harbor and NJDOT.
