Board of Health ORDINANCE 2024-01

AN ORDINANCE BY THE TOWNSHIP OF LITTLE EGG HARBOR BOARD OF HEALTH, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING THE TOWNSHIP CODE SO AS TO AMEND CHAPTER 352, FOOD ESTABLISHMENTS, RETAIL

NOW, THEREFORE, BE IT ORDAINED, by the Board of Health of the Township of Little

Egg Harbor, County of Ocean, State of New Little Egg Harbor, as follows:

SECTION 1. That the Board of Health hereby amends Chapter 352, entitled

"Food Establishments, Retail" so as to amend and supplement §352-1, entitled "License required"

so as to replace the section as follows:

§352-1 License required; compliance with Retail Food Establishment Code

No retail food establishment may operate or otherwise conduct business in the Township of Little Egg Harbor without having first procured a license to operate from either the County Board of Health or the Township Board of Health. All retail food establishments in the Township must also comply with the <u>N.J.A.C.</u> 8:24-1.1 to -10.2, Retail Food Establishment Code, and any amendments thereto, as and any retail food establishment in violation of the Retail Food Establishment Code shall be declared a nuisance and hazardous to health.

SECTION 2. That the Board of Health hereby amends Chapter 352, entitled

"Food Establishments, Retail" so as to amend §352-5, entitled "Conspicuous posting of

license" in its entirety as follows:

§352-5 Conspicuous posting of license

Any license issued hereunder shall be posted in a conspicuous place in such establishment.

SECTION 3. That the Board of Health hereby amends Chapter 352, entitled

"Food Establishments, Retail" so as to amend §352-6, entitled "Application for yearly or

seasonal license; renewal; expiration" so as to amend Subsection A to add the following

sentence to the end of the Paragraph:

"Failure to comply with the requirements for submitting a certificate of insurance evidencing minimum liability insurance as required under P.L. 2022, c. 92, may subject the owner of a retail food establishment to a summary proceeding pursuant to <u>N.J.S.A.</u> 2A:58-10 <u>et seq.</u> whereby the Township may collect a fine of not less than \$500, but no more than \$5,000, against an owner failing to comply with the law."

SECTION 4. That the Board of Health hereby amends Chapter 352, entitled

"Food Establishments, Retail" so as to omit §352-7, entitled "Food Handler's certificate

required" in its entirety and replace it with "Reserved."

SECTION 5. That the Board of Health hereby amends Chapter 352, entitled

"Food Establishments, Retail" so as to omit §352-8, entitled "Application of chapter shall

not impose burden" in its entirety and replace it with "Reserved."

SECTION 6. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 7. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 8. This ordinance shall take effect after second reading and publication as required by law.
