

RESOLUTION NO. 2024-121

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, SUPPORTING 9TH DISTRICT LEGISLATORS EFFORTS TO ENSURE PROPER STATE SCHOOL AID TO LITTLE EGG HARBOR SCHOOL DISTRICT AND PINELANDS REGIONAL SCHOOL DISTRICT UNDER S-3075/A-4166

WHEREAS, Little Egg Harbor School District is facing a more than \$1.5 million aid cut and Pinelands Regional stands to lose nearly \$2 million in aid; and

WHEREAS, the school districts face imposing mandates from the State, which may force school districts to eliminate teaching positions and increase class sizes, affecting the quality of education for our students; and

WHEREAS, the governing body of the Township of Little Egg Harbor strongly opposes the cut in school aid to its school districts; and

WHEREAS, the Township of Little Egg Harbor strongly supports the efforts of the 9th District Legislators in its efforts to pass legislation (S-3075/A-4166) that would ensure that the amount of State school aid disbursed to a district in a school year would not be reduced by more than one percent of the prior year's amount of school aid.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body of Little Egg Harbor Township strongly supports the efforts of the 9th District Legislators in its efforts to pass legislation (S-3075/A-4166) that would ensure that the amount of State school aid disbursed to a district in a school year would not be reduced by more than one percent of the prior year's amount of school aid.
