**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE RECEIPT OF BIDS FOR THE PURCHASE AND INSTALLATION OF ONE (1) CHILLER UNIT LOCATED AT THE LITTLE EGG HARBOR MUNICIPAL BUILDING AND AUTHORIZING THE TOWNSHIP QUALIFIED PURCHASING AGENT TO PREPARE PLANS AND SPECIFICATIONS FOR SAID PROJECT**

**WHEREAS**, the Township requires the purchase and installation of one (1) Chiller Unit located at the Little Egg Harbor Municipal Building in the Township of Little Egg Harbor; and

**WHEREAS**, the anticipated cost for the purchase and installation of one (1) Chiller Unit located at the Little Egg Harbor Municipal Building is expected to exceed \$17,500.00, so as to require public bidding in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

**WHEREAS**, it is the desire of the governing body to advertise for and receive bids for the purchase and installation of one (1) Chiller Unit located at the Little Egg Harbor Municipal Building and further authorize the Township qualified Purchasing Agent to prepare the plans and bid specifications for said project.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the receipt of bids for the purchase and installation of one (1) Chiller Unit located at the Little Egg Harbor Municipal Building. The Township shall determine the time, date and place for the receipt of said bids.


2. That the Township Qualified Purchasing Agent is hereby authorized to prepare the plans and bid specifications for said project.
