**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE RECEIPT OF BIDS FOR RENOVATION AND IMPROVEMENTS TO THE TOWNSHIP OF LITTLE EGG HARBOR MUNICIPAL BUILDING AND AUTHORIZING THE TOWNSHIP ENGINEER TO PREPARE PLANS AND SPECIFICATIONS FOR SAID PROJECT**

**WHEREAS**, the Township requires that renovation and improvements be made to the Little Egg Harbor Municipal Building, located in the Township of Little Egg Harbor; and

**WHEREAS**, the anticipated cost for Renovation and Improvements to the Little Egg Harbor Municipal Building Project is expected to exceed \$17,500.00, so as to require public bidding in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

**WHEREAS**, it is the desire of the governing body to advertise for and receive bids for Renovation and Improvements to the Little Egg Harbor Municipal Building Project, and further to authorize the Township Engineer to prepare the plans and bid specifications for said project.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the receipt of bids for Renovation and Improvements to the Little Egg Harbor Municipal Building Project. The Township shall determine the time, date and place for the receipt of said bids.

2. That the Township Engineer is hereby authorized to prepare the plans and bid specifications for said project.
