

RESOLUTION NO. 2024-137

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, REJECTING ALL BIDS RECEIVED FOR DEMOLITION OF THE STRUCTURE LOCATED AT 360 ROUTE 9 SOUTH (BLOCK 291, LOT 8) AND AUTHORIZING THE RE-ADVERTISEMENT AND RECEIPT OF BIDS

WHEREAS, the Township of Little Egg Harbor duly advertised for the receipt of bids for the Demolition of the Structure located at 360 Route 9 South (Block 291, Lot 8); and

WHEREAS, eight (8) bids were received on April 24, 2024, in response to the invitation to bidders; and

WHEREAS, it is the desire of the governing body to reject said bids in accordance with N.J.S.A. 40A:11-13.2(f) as a result of the late addendum outside of the statutory limit; and

WHEREAS, it is the desire of the governing body to advertise for and receive bids for Demolition of the Structure located at 360 Route 9 South (Block 291, Lot 8)

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That in accordance with N.J.S.A. 40A:11-13.2(f), the governing body does hereby reject all bids received for the Demolition of the Structure located at 360 Route 9 South (Block 291, Lot 8) as a result of the late addendum outside of the statutory limit.

2. That the governing body does hereby authorize the receipt of new bids for the Demolition of the Structure located at 360 Route 9 South (Block 291, Lot 8) as a result of the rejection of all bids due to the late addendum outside of the statutory limit. The Township Clerk, Township Qualified Purchasing Agent and/or the Township Administrator shall determine the time, date and place for the receipt of said bids.


