### 13. TOWNSHIP ENGINEER COMMENTS

Township Engineer, Jason Worth, reported the work at the Recreation Complex is wrapping up and the contractors have completed the pickle ball and basketball courts, pavilions and the batting cages. He stated they are in the process of completing the punch list to finalize everything to close out the project. He stated the drainage project is being completed by Mathis Construction and all the drainage work has been completed and the final restoration and paving is currently being done to finalize the project. He further reported the design plans are being wrapped up for storm drainage and roadway improvements on East and West Potomac, East and West Susquehanna, East and West Raritan and East and West Shrewsbury and they will be submitted to the NJDEP for approval by May 24, 2024. He stated the MUA had their bid opening on those streets and they should be awarding them soon. He stated once the MUA has completed their project, the Township can go out to bid to do theirs.
