RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE SUBMISSION OF AN APPLICATION FOR THE 2024 HORIZON BLUE CROSS BLUE SHIELD OF NEW JERSEY FITNESS CAMPAIGN GRANT
