RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE SUBMISSION OF A LOAN APPLICATION WITH THE NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION AND THE NEW JERSEY INFRASTRUCTURE BANK FOR MYSTIC ISLAND DRAINAGE IMPROVEMENTS PHASE 3, NJIB LOAN NO. S340579-06

WHEREAS, the Township of Little Egg Harbor intends to file a loan application with the New Jersey Department of Environmental Protection and the New Jersey Infrastructure Bank for the Township's Mystic Island Drainage Improvements Phase 3 Project; and

WHEREAS, the proposed project includes the replacement of approximately 1,500 lineal feet (LF) and removal of 50 LF of existing drainage piping, installation of approximately 880 LF of new drainage piping. The work also includes replacement of 11 outfalls and replacement and installation of up to 35 drainage inlets, as well as, in kind restoration of approximately 17,150 square feet of existing storm drainage easements, and roadway reconstruction along West and East Raritan Drive, West and East Potomac Drives, West and East Susquehanna Drives, and West and East Shrewsbury Drives from edge to edge once all construction is completed.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That Rodney R. Haines, Township Chief Financial Officer, be authorized to act as the Authorized Representative to represent the Township in all matters relating to the project undertaken pursuant to the above referenced New Jersey Environmental Infrastructure Loan to be executed with the New Jersey Department of Environmental Protection and the New Jersey Environmental Infrastructure Trust. 
