14. TOWNSHIP ENGINEER COMMENTS

Township Engineer Jason Worth, reported the 2023 road improvement program is underway and the contractor is currently working on concrete improvements on Oak Lane and drainage crews wrapped up the drainage on Cranbury Lake Drive and will be continuing on additional roads next week. He stated they are paving a portion of Oak Lane the last week of August prior to school starting back. He stated paving will also be done on Daryl Drive and East Thames Road and the remainder of the roads will be done once the drainage and concrete is complete. He stated that the township submitted an application for the Safe Routes to School grant last fall including curb, sidewalk, handicap ramp, stripping and signage along Frog Pond Road, a portion of Parkertown Drive and Railroad Avenue and the state issued a \$800,000 grant for the project. He also reported the township submitted a grant this past spring to NJDOT Local Transportation Project Fund for sidewalks, curbing, handicap ramps, stripping, crosswalks, bike lanes and signage on Radio Road from Oak Lane to Country Club Blvd, which the township was awarded \$950,000 in grant funding.

Mr. Brown of N. Burgee Drive thanked the Committee for tabling the bench program. He questioned how an ordinance gets put on the agenda, then specifically spoke about putting a chain ordinance in place.

Township Attorney, Melanie Appleby, stated in this form of government an ordinance is developed by the governing body and the professionals. She stated bringing it to the governing body and professional's attention then allows the attorney to look into the issue to determine what can/cannot be done, the pitfalls and what has been done in other jurisdictions in order to draft something for the Committee to review and discuss internally.

Mr. Curtin of Mayflower Drive asked about the Safe Routes to School project schedules. He also requested that the four to five properties on Oak Lane going into Tuckerton get added into a project for sidewalks. He stated this would connect the Little Egg and Tuckerton sidewalks.

Township Administrator, Rodney Haines, stated currently the SRTS project is in the design stage with an engineer who was selected and paid for by the state for the project. He stated the last he spoke with the state they told him the design stage would be atleast a year.

Township Engineer, Jason Worth, stated he will certainly look into the sidewalks for the four to five homes on Oak Lane to see if they can be added into a local project.
