

**RESOLUTION NO. 2024-233**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TAX COLLECTOR TO CANCEL TAXES AND PROVIDE A REFUND PURSUANT TO N.J.S.A. 54:4-3.30 ON PROPERTY QUALIFYING FOR VETERANS PROPERTY TAX EMEMPTION (GEOVANNI IRIZARRY, BLOCK 325.61, LOT 20)**

**WHEREAS, N.J.S.A. 54:4-3.30** provides for an exemption from property taxes on certain property owned by a totally-disabled Veteran; and

**WHEREAS,** it has been determined by the Tax Assessor that property known as Block 325.61, Lot 20, owned by Geovanni Irizarry, qualified for a Veterans' Property Tax Exemption in the year 2024; and

**WHEREAS,** the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and

**WHEREAS,** the Tax Collector has requested authorization to cancel property taxes, in the amount of \$3,267.64; and

**WHEREAS,** pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally-disabled veterans portion of the 2024 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and

**WHEREAS,** the Tax Collector deems that the Mortgage Company, Lereta Service Agent, receive a refund on taxes already paid for the year 2024 in the amount of \$264.14; and

**NOW, THEREFORE, BE IT RESOLVED,** by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes in the amount of \$3,267.64 for the year 2024 for Block 325.61, Lot 20, owned by Geovanni Irizarry and authorize a refund to Lereta Service Agent, in the amount of \$264.14.

2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor, Geovanni Irizarry, Lereta Service Agent and the Chief Financial Officer.



WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from taxes on certain property owned by a totally-disabled veteran; and





WHEREAS, the Tax Collector has requested authorization to cancel property taxes for 2024 based upon a prorated assessment of \$134,100 applied by the F02 Tax Rate, taxes outstanding that would otherwise be exempt.
