

RESOLUTION NO. 2024-282

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TAX COLLECTOR TO CANCEL TAXES PURSUANT TO N.J.S.A. 54:4-3.30 ON PROPERTY QUALIFYING FOR VETERANS PROPERTY TAX EMEMPTION (JOHN BUONADONNA, BLOCK 325.113, LOT 11)

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from property taxes on certain property owned by a totally-disabled Veteran; and

WHEREAS, it has been determined by the Tax Assessor that property known as Block 325.113, Lot 11, owned by John Buonadonna, qualified for a Veterans' Property Tax Exemption in the year 2024; and

WHEREAS, the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and

WHEREAS, the Tax Collector has requested authorization to cancel property taxes and remove the added/omitted from the 2024 tax sale list, in the amount of \$1,572.63; and

WHEREAS, pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally-disabled veterans portion of the 2024 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes and remove the added/omitted from the 2024 tax sale list, in the amount of \$1,572.63 for Block 325.113, Lot 11, owned by John Buonadonna.

2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor, John Buonadonna and the Chief Financial Officer.



ASSESSMENT CREDIT WORKSHEET






WHEREAS, the Tax Collector has requested authorization to cancel property taxes for 2024 based upon a prorated assessment of \$219,000 applied by the F02 Tax Rate, taxes outstanding that would otherwise be exempt.
