

RESOLUTION 2025-152

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR,
COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE
MUNICIPAL TAX COLLECTOR TO PREPARE AND MAIL ESTIMATED
TAX BILLS IN ACCORDANCE WITH N.J.S.A. 54:4-66.3**

WHEREAS, it is anticipated that the Township Tax Collector will not be in receipt of a certified tax rate in enough time it be able to complete the mailing and delivery of real property tax bills by June 14, 2025 as required by law; and.

WHEREAS, the Little Egg Harbor Township Tax Collector and the Little Egg Harbor Township Chief Financial Officer have requested that the Township Committee provide them with the latitude to submit estimated 3rd quarter real property tax bills in the event that they do not receive a certified tax rate which would allow the Tax Collector to complete the mailing and delivery of real property tax bills in accordance with the guidelines; and

WHEREAS, the municipal Tax Collector in consultation with the municipal Chief Finance Officer has computed an estimated tax levy in accordance with N.J.S.A. 54:4-66.3, and they have signed a certification showing the levies for the previous year and the tax rates.

NOW THEREFORE, BE IT RESOLVED, that the Township Committee of the Little Egg Harbor Township, County of Ocean, State of New Jersey, hereby authorized that:

1. The Municipal Tax Collector is hereby authorized and directed to prepare, and issue estimated tax bills for the Township of Little Egg Harbor for the third installment of 2025 taxes in accordance with the provisions of N.J.S.A. 54:4-66.2 and 54:4-66.3.
2. The entire estimated tax levy for 2025 is hereby set at \$74,395,767.23 based upon a calculation of 105% of the 2024 tax levy. The estimated tax rates for 2025 is hereby set as general tax rate \$3.038; Fire District #1 \$0.076; Fire District #2 \$0.056; and Fire District #3 \$0.123.
3. In accordance with law, the third quarter installment of 2025 shall not be subject to interest until after the later of the end of the grace period, or the twenty-fifth calendar day after the date the estimated tax bills were mailed. The estimated tax bills shall contain a notice specifying the date on which interest may begin to accrue.
4. That a copy of this Resolution be forwarded to the Tax Collector and Chief Financial Officer of the Township of Little Egg Harbor for their records.
