

RESOLUTION 2025-207

RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TAX COLLECTOR TO CANCEL TAXES AND PROVIDE A REFUND PURSUANT TO N.J.S.A. 54:4-3.30 ON PROPERTY QUALIFYING FOR VETERANS PROPERTY TAX EMEMPTION (JOYCE L. CAVILEER, BLOCK 285.11, LOT 4)

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from property taxes on certain property owned by a totally-disabled Veteran; and

WHEREAS, it has been determined by the Tax Assessor that property known as Block 285.11, Lot 4, owned by Joyce L. Cavileer, qualified for a Veterans' Property Tax Exemption widower in the year 2025; and

WHEREAS, the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and

WHEREAS, the Tax Collector has requested authorization to cancel property taxes, in the amount of \$4,586.40; and

WHEREAS, pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally-disabled veterans portion of the 2025 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and

WHEREAS, the Tax Collector deems that the Mortgage Company, Lcrcta, receive a refund on taxes already paid for the year 2025 in the amount of \$2,131.72; and


NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Occan, State of New Jersey as follows:

1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes in the amount of \$4,586.40, for the year 2025 for Block 285.11, Lot 4, owned by Joyce L. Cavileer and authorize a refund to Lereta, in the amount of \$2,131.72.

2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor, Joyce L. Cavileer, Lereta and the Chief Financial Officer.



ASSESSMENT CREDIT WORKSHEET

WHEREAS, it has been determined by the Tax Assessor that the property known as Block 285.11 Lot 4 owned by Cavileer, Joyce L qualifies for a Veteran's Property Tax Exemption as of June 2, 2025.






