

**RESOLUTION 2025-225**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TAX COLLECTOR TO CANCEL TAXES AND PROVIDE A REFUND PURSUANT TO N.J.S.A. 54:4-3.30 ON PROPERTY QUALIFYING FOR VETERANS PROPERTY TAX EMEMPTION (THOMAS S. LIMOZINERE, BLOCK 325.50, LOT 33)**

**WHEREAS, N.J.S.A. 54:4-3.30** provides for an exemption from property taxes on certain property owned by a totally-disabled Veteran; and

**WHEREAS,** it has been determined by the Tax Assessor that property known as Block 325.50, Lot 33, owned by Thomas S. and Katherine Limozinere, qualified for a Veterans' Property Tax Exemption in the year 2025; and

**WHEREAS,** the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and

**WHEREAS,** the Tax Collector has requested authorization to cancel property taxes, in the amount of \$3,677.40; and

**WHEREAS,** pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally-disabled veterans portion of the 2025 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and

**WHEREAS,** the Tax Collector deems that the Title Company, Seber Title and Settlement Services, receive a refund on taxes already paid for the year 2025 in the amount of \$1,617.86; and

**NOW, THEREFORE, BE IT RESOLVED,** by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes in the amount of \$3,677.40, for the year 2025 for Block 325.50, Lot 33, owned by Thomas S. and Katherine Limozinere and authorize a refund to Seber Title and Settlement Services, in the amount of \$1,617.86.

2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor, Thomas S. and Katherine Limozinere, Seber Title and Settlement Services and the Chief Financial Officer.

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from taxes on certain property owned by a totally-disabled veteran; and



WHEREAS, the Tax Collector has requested authorization to cancel property taxes for 2025 based upon a prorated assessment of \$228,500 applied by the F02 Tax Rate, taxes outstanding that would otherwise be exempt.
