RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE EXECUTION OF A SHARED SERVICES AGREEMENT WITH THE TOWNSHIP OF BARNEGAT FOR INTERIM CHIEF FINANCIAL OFFICER, THOMAS LOMBARSKI

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq. (the "Act"), authorizes local units of this State to enter into agreements with any other local unity or units to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive in its own jurisdiction; and

WHEREAS, due to an unexpected emergent leave by the Little Egg Harbor Township CFO, the Township is in immediate need of financial services from a Certified Financial Officer; and

WHEREAS, Thomas Lombarski, CPA, MRA, presently serves neighboring Barnegat Township as Chief Financial Officer and Barnegat Township has agreed to a Shared Services Agreement with Little Egg Harbor Township as to providing the necessary financial services of Mr. Lomarski; and

WHEREAS, in the spirit of inter-municipal cooperation, and in furtherance of the principles underlying the Act, the Township of Little Egg Harbor and the Township of Barnegat desire to enter into a Shared Services Agreement for the financial services of Thomas Lombarski, Chief Financial Officer of Barnegat Township in accordance with the submitted proposal.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorize the execution of a Shared Services Agreement with the Township of Barnegat, attached hereto as Schedule A, in a form acceptable to the Little Egg Harbor Township Attorney, for the purpose of setting the terms and conditions.

2. That the Mayor is hereby authorized to execute and the Township Clerk to attest to the Shared Services Agreement, and any other documents necessary to effectuate the terms of this resolution.

3. That the term of the agreement shall be for thirty (30) days, as a month-to-month agreement.


4. That the agreement shall become effective upon the passage of Resolutions by both Barnegat Township and Little Egg Harbor Township and the full execution by both parties.

5. That a copy of the agreement referenced herein shall be kept on file and made available for public inspection at the Township Clerk's Office during normal business hours.

6. That a certified copy of this resolution, together with a copy of the agreement, shall be forwarded to Barnegat Township Administrator, Barnegat Township CFO Thomas Lombarski and Little Egg Harbor Township Interim Township Administrator, Kelly Lettera.
