

**RESOLUTION 2025-241**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TAX COLLECTOR TO CANCEL TAXES AND PROVIDE A REFUND PURSUANT TO N.J.S.A. 54:4-3.30 ON PROPERTY QUALIFYING FOR VETERANS PROPERTY TAX EMEMPTION (MICHAEL DIFRANCIA, BLOCK 169, LOT 1.03)**

**WHEREAS**, N.J.S.A. 54:4-3.30 provides for an exemption from property taxes on certain property owned by a totally-disabled Veteran; and

**WHEREAS**, it has been determined by the Tax Assessor that property known as Block 169, Lot 1.03, owned by Michael and Alexis DiFrancia, qualified for a Veterans' Property Tax Exemption in the year 2025; and

**WHEREAS**, the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and

**WHEREAS**, the Tax Collector has requested authorization to cancel property taxes, in the amount of \$3,238.50; and

**WHEREAS**, pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally-disabled veterans portion of the 2025 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and

**WHEREAS**, the Tax Collector deems that the Mortgage Company, Corelogic, receive a refund on taxes already paid for the year 2025 in the amount of \$452.58; and


**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes in the amount of \$3,238.50, for the year 2025 for Block 169, Lot 1.03, owned by Michael and Alexis DiFrancia and authorize a refund to Corelogic, in the amount of \$452.58.

2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor, Michael and Alexis DiFrancia, Corelogic and the Chief Financial Officer.



**ASSESSMENT CREDIT WORKSHEET**



WHEREAS, the Tax Collector has requested authorization to cancel property taxes for 2025 based upon a prorated assessment of \$279,500 applied by the F03 Tax Rate, taxes outstanding that would otherwise be exempt.
