**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE TRANSFERS OF APPROPRIATIONS IN ACCORDANCE WITH N.J.S.A. 40A:4-58**

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

**A.** That the governing body hereby authorizes the Township Deputy Chief Financial Officer to make transfers in accordance with N.J.S.A. 40A:4-58 as set forth on the attached Exhibit A.

**B.** That a copy of this resolution shall be served upon the Chief Financial Officer for the Township of Little Egg Harbor.
