RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING USE OF 2019 FORD E-450 SUPER DUTY VEHICLE BY GREAT BAY REGIONAL VOLUNTEER EMERGENCY MEDICAL SERVICES, INC., A NON-PROFIT CORPORATION, FOR FIRST AID AND EMERGENCY MEDICAL SERVICES

WHEREAS, Great Bay Regional Volunteer Emergency Medical Services, Inc. (“Great Bay EMS”) desires to utilize a 2019 Ford E-450 Super Duty Vehicle owned by the Township of Little Egg Harbor; and

WHEREAS, N.J.S.A. 40:5-2 authorizes the Township to appropriate such additional sums as it may deem necessary for the purchase of first aid, ambulance, rescue or other emergency vehicles, equipment, supplies and materials for use by these associations, so long as the title to which shall remain with municipality, and the funds are controlled and disbursed by the municipality; and

WHEREAS, it is the desire of the Township Committee to authorize Great Bay Regional Volunteer Emergency Medical Services, Inc to use the Township-owned 2019 Ford E-450 Super Duty Vehicle for first aid and emergency medical services, in accordance with N.J.S.A. 40:5-2.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Little Egg Harbor, as follows:

1. That the governing body does hereby authorize Great Bay Regional Volunteer Emergency Medical Services, Inc to use the Township’s 2019 Ford E-450 Super Duty Vehicle in accordance with the terms of this resolution and N.J.S.A. 40:5-2.


