

ORDINANCE 2026-01

AN ORDINANCE OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 86 OF THE TOWNSHIP CODE ENTITLED “OFFICERS AND EMPLOYEES” SO AS TO CREATE ARTICLE LXXXIV, ASSISTANT CONSTRUCTION OFFICIAL

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

SECTION 1. That the governing body hereby amends and supplements Chapter 86 of the Township Code entitled “Officers and Employees” so as to create Article LXXXIV, entitled “Assistant Construction Official” as follows:

Article LXXXIV Assistant Construction Official

§86-198 Position created

There is hereby created the position of Assistant Construction Official for the Township of Little Egg Harbor.

§86-197 Duties; qualifications

- A.** Under the direction of the Township Construction Official, the Assistant Construction Official assists the Construction Official in overall administrative responsibility for administering and enforcing provisions of the New Jersey Uniform Construction Code; does other related duties as required.
- B.** The Assistant Construction Official shall assume all duties, responsibilities and authority of the Construction Official in his/her absence.
- C.** In order to be appointed to the position of Assistant Construction Official, an individual shall possess the following:
 - 1. A valid construction official's license issued by the Department of Community Affairs.
 - 2. A driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

3. Where the Construction Official also serves as one or more subcode officials, the Construction Official shall be required to possess the appropriate subcode license or licenses.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
