RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, APPOINTING THE MAYOR AS A CLASS I MEMBER, KATHERINE TUCKER AS A CLASS II MEMBER, COMMITTEEMAN DANIEL MAXWELL AS A CLASS III MEMBER, AND ROBERTA RAPISARDI AND GEORGE GARBARAVAGE AS CLASS IV MEMBERS AND MADALYNN FLYNN AS AN ALTERNATE MEMBER OF THE PLANNING BOARD

WHEREAS, the Township of Little Egg Harbor has determined that there is a need for appointments to the Township Planning Board; and

WHEREAS, N.J.S.A. 40:55D-23 provides that the membership of the Planning Board shall consist of Class I, Class II, Class III, Class IV and alternate appointees.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That the Mayor is hereby appointed as the Class I member of the Little Egg Harbor Township Planning Board for a term of one year. Said term shall commence on January 1, 2026 and expire on December 31, 2026.

2. That Katherine Tucker is hereby appointed as the Class II member of the Little Egg Harbor Township Planning Board for a term of one year. Said term shall commence on January 1, 2026 and expire on December 31, 2026.

3. That Committeeman Daniel Maxwell is hereby appointed as the Class III member of the Little Egg Harbor Township Planning Board for a term of one year. Said term shall commence on January 1, 2026 and expire on December 31, 2026.

4. That Roberta Rapisardi is hereby appointed as a Class IV Member of the Little Egg Harbor Township Planning Board for an unexpired term. Said term shall commence on January 1, 2026 and expire on December 31, 2027.


5. George Garbaravage is hereby appointed as a Class IV Member of the Little Egg Harbor Township Planning Board. Said term shall commence on January 1, 2026 and expire on December 31, 2029.

6. That Madalynn Flynn is hereby appointed as an Alternate Member of the Little Egg Harbor Township Planning Board for a two year term. Said term shall commence on January 1, 2026 and expire on December 31, 2027.
