**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, APPOINTING MEMBERS TO THE FLOODPLAIN MANAGEMENT PLAN COMMITTEE**

**WHEREAS**, Chapter 49 of the Township Code of the Township of Little Egg Harbor authorizes a Floodplain Management Plan Committee to assist the Township in preparing a Floodplain Management Plan within the Township; and

**WHEREAS**, the Township Committee desires to appoint the following ex officio members to the Floodplain Management Plan Committee:

1. Michael Fromosky, representing the Building Department/Code Enforcement, for a term of two years commencing January 1, 2026 and expiring December 31, 2027;
2. Jason Worth, representing Engineering, for a term of two years commencing January 1, 2026 and expiring December 31, 2027;
3. John Cooley, representing Land Use Planning/Zoning and Housing and Community Development, for a term of two years commencing January 1, 2026 and expiring December 31, 2027;
4. Brad Griffin, Superintendent of Public Works, representing Public Works/Parks & Recreation, for a term of two years commencing January 1, 2026 and expiring December 31, 2027;
5. Chief of Police, representing Public Safety/Emergency Management for a term of two years commencing January 1, 2026 and expiring December 31, 2027;
6. Township Administrator, representing Public Information, for a term of two years commencing January 1, 2026 and expiring December 31, 2027;
7. Thomas Thornton, representing Environmental Protection/Public Health, for a term of two years commencing January 1, 2026 and expiring December 31, 2027;

8. Township Committeeman John Kehm, representing the Township Committee, for a term of two years commencing January 1, 2026 and expiring December 31, 2027;


**WHEREAS**, all members of the Floodplain Management Plan Committee shall serve without compensation.

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That Michael Fromosky, Jason Worth, John Cooley, Brad Griffin, Chief of Police, Township Administrator, Thomas Thornton and John Kehm are appointed as ex officio members of the Floodplain Management Plan Committee for a term of two years commencing January 1, 2026 and expiring December 31, 2027.
2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to Michael Fromosky, Jason Worth, John Cooley, Brad Griffin, Chief of Police, Township Administrator, Thomas Thornton and John Kehm.
