

ORDINANCE 2026-09

AN ORDINANCE OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 238, MEMORIAL BENCH DEDICATION PROGRAM

NOW, THEREFORE, BE IT ORDAINED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

SECTION 1. That the governing body hereby amends and supplements Chapter 238 of the Township Code entitled “Memorial Bench Dedication Program” so as to amend §238-2(A)(1), “General Regulations” in its entirety as follows:

§ 238-2 General regulations.

A. Memorial plaques shall be installed on benches in accordance with the following regulations:

(1) The fee for a dedicated bench and memorial plaque shall be determined annually by the Township Committee, based on reasonable costs and expense for materials, said fee to be memorialized by resolution.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
