

**RESOLUTION 2026-123**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE SALE OF SURPLUS PERSONAL PROPERTY BY OPEN PUBLIC AUCTION IN ACCORDANCE WITH N.J.S.A. 40A:11-36, N.J.S.A. 40A:12-13 AND N.J.A.C. 5:34-5.8**

**WHEREAS**, the Township of Little Egg Harbor desires to sell the following personal property, no longer needed for public use, in accordance with N.J.S.A. 40A:11-36 and N.J.S.A. 40A:12-13, as described on Exhibit A, attached hereto; and

**WHEREAS**, the Township has set a minimum reserve price for each item listed, and reserves the right to reject all bids in the event that the highest bid is not accepted; and

**WHEREAS**, the Township will utilize Sourcewell National Cooperative, Contract #012821-GDI (GovDeals) to conduct the auction in accordance with P.L. 2011, c.139 and N.J.A.C. 5:34-5.8 (sale of surplus property); and

**WHEREAS**, that the highest bids will be reviewed and accepted or rejected, with the governing body delegating the authority to the purchasing agent to accept or reject bids on any item where the winning bid comes in under the Township's bid threshold, pursuant to N.J.A.C. 5:34-5.8(d).

**NOW, THEREFORE, BE IT RESOLVED**, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the governing body does hereby authorizes the sale of the surplus property no longer needed by the Township for public use and listed on the attached Exhibit "A", by an online sale conducted through Sourcewell National Cooperative (GovDeals, Inc.) in accordance with the terms of this Resolution.

2. The sale will be conducted online in accordance with N.J.A.C. 5:34-5.8 and the address of the auction site is www.govdeals.com.

3. The sale of surplus property shall be conducted through Sourcewell National Cooperative, Contract number Contract #012821-GDI (GovDeals, Inc. (GovDeals.com)) in accordance with the terms and conditions of the national cooperative Contract. The terms and conditions of the agreement entered into with Sourcewell National Cooperative, Contract #012821-GDI (GovDeals, Inc. (GovDeals.com)) is available online at https://www.sourcewell-mn.gov.

4. That the Township Clerk shall prepare a notice for advertisement pursuant to N.J.A.C. 5:34-9.8(f) for a newspaper publication circulating in the Township, announcing the auction, the general description of the surplus property to be sold, indicating the internet address for the sale that is being advertised, including the date and time of the online auction, that the Township has set a minimum reserve price for each item listed, and reserves the right to reject all bids in the event that the highest bid is not accepted.

5. That the Township Clerk shall advertise the notice in Paragraph 5 above in a newspaper circulating in the Township, and the online sale shall commence not less than seven (7) nor more than fourteen (14) days after the publication of the advertisement.

6. That a certified copy of this resolution shall be forwarded to the Chief Financial Officer, Purchasing Agent, Sourcewell National Cooperative, and the Department of Community Affairs.
