**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG HARBOR,
COUNTY OF OCEAN, STATE OF NEW JERSEY, ACCEPTING THE
RETIREMENT OF AND AUTHORIZING THE COMPENSATION OF
ACCUMULATED TIME TO SEAN CROTTY**

WHEREAS, Sean Crotty submitted a request for retirement from the Township as of July 1, 2025;
and

WHEREAS, as of the date of his retirement, Sean Crotty accumulated 761 hours of unused time over the course of his employment with the Township of Little Egg Harbor; and

WHEREAS, on July 10 2025, by Resolution 2025-170 the Township accepted the retirement of and authorized the compensation of accumulated time to Mr. Crotty in the amount of \$38,469.23; and

WHEREAS, Resolution 2025-170 and the previous payout sheet received from the Finance Department was not calculated accurately; and

WHEREAS, Sean Crotty is entitled to compensation for a total of 233.25 hours for unused vacation time in the amount of \$17,794.64; 256.75 hours for unused sick time in the amount of \$9,795.01; 31 hours of unused personal time in the amount of \$2,364.99; 240 hours of unused comp time in the amount of \$18,309.60, for a total payment of \$48,264.24; and

WHEREAS, Mr. Crotty was paid monthly from July 25, 2025 through February 2026 in the amount of \$38,469.23; and

WHEREAS, there are three remaining payments to be paid monthly through August 7, 2026 in the amount of \$9,795.01.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Governing body does hereby authorize final payment to Sean Crotty in the amount of \$9,795.01, which shall be paid in full on July 24, 2026.
2. That a certified copy of this resolution shall be sent to Sean Crotty, Civil Service Commission and Chief Financial Officer.
