

RESOLUTION 2026-221

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG
HARBOR, COUNTY OF OCEAN, STATE OF NEW
JERSEY, AUTHORIZING THE TAX COLLECTOR TO
CANCEL TAXES AND PROVIDE A REFUND PURSUANT
TO N.J.S.A. 54:4-3.30 ON PROPERTY QUALIFYING FOR
VETERANS PROPERTY TAX EMEMPTION (GARY
DECKER, BLOCK 282, LOT 6.72)**

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from property taxes on certain property owned by a totally-disabled Veteran; and

WHEREAS, it has been determined by the Tax Assessor that property known as Block 282, Lot 6.72, owned by Gary Decker, qualified for a Veterans' Property Tax Exemption in the year 2026; and

WHEREAS, the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and

WHEREAS, the Tax Collector has requested authorization to cancel property taxes, in the amount of \$5,170.76; and

WHEREAS, pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally-disabled veterans portion of the 2026 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and

WHEREAS, the Tax Collector deems that the owner, Gary Decker, receive a refund on taxes already paid for the year 2026 in the amount of \$568.87; and

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes in the amount of \$5,170.76, for the year 2026 for Block 282, Lot 6.72, owned by Gary Decker and authorize a refund to the owner, in the amount of \$568.87.

2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor, Gary Decker and the Chief Financial Officer.

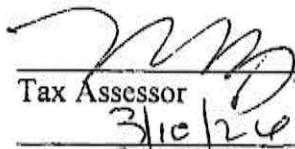

TOTALLY DISABLED VETERAN
ASSESSMENT CREDIT WORKSHEET

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from taxes on certain property owned by a totally-disabled veteran; and

WHEREAS, it has been determined by the Tax Assessor that the property known as Block 282 Lot 6.72 owned by Decker, Gary qualifies for a Veteran's Property Tax Exemption as of February 19, 2026.

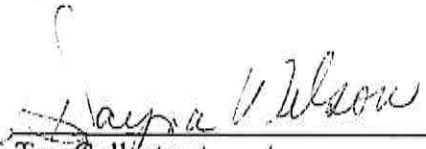

WHEREAS, the determination by the Tax Assessor is the result of an assignment of a one hundred percent permanent and total wartime service-connected disability evaluation from the Veterans Administration; and

WHEREAS, the Tax Collector has requested authorization to cancel property taxes for 2026 based upon a prorated assessment of \$174,100 applied by the F01 Tax Rate, taxes outstanding that would otherwise be exempt.

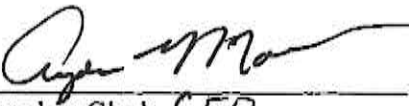
