

RESOLUTION 2026-253

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG
HARBOR, COUNTY OF OCEAN, STATE OF NEW
JERSEY, AUTHORIZING AN AMENDMENT TO THE
2026 BUDGET TO ALLOW FOR THE INSERTION OF A
SPECIAL ITEM OF REVENUE AND APPROPRIATION
PURSUANT TO N.J.S.A. 40A:4-87**

WHEREAS, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any local unit when such item shall have been made available by any public or private funding source and the amount thereof shall not have been determined at the time of the adoption of the budget; and

WHEREAS, N.J.S.A. 40A:4-87 further provides that the Director may approve the insertion of an appropriation item of an amount equal to any such special item of revenue making such item of revenue available for expenditures; and

WHEREAS, the Township of Little Egg Harbor has received award of \$2,036.00 from the National Wildlife Refuge Fund (Revenue Sharing) FY 2026 payments for 2025; and

WHEREAS, the governing body desires to amend the 2026 budget to include this amount.

NOW, THEREFORE, BE IT RESOLVED, by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey, as follows:

1. That the governing body does hereby authorize an amendment to the 2026 budget to provide for the insertion of a special item of revenue in the amount of \$2,036.00 contingent upon approval by the Director of the Division of Local Government Services, which sum will be available as revenue from:

State and Federal Revenues Offset with Appropriations:

\$2,036.00 from the National Wildlife Refuge Fund (Revenue Sharing) FY 2026 for payments for 2025

2. That the governing body hereby further authorizes an appropriation of an equal sum under the caption of:

General Appropriations: (Operations excluded from CAP)

State & Federal Programs Offset by Revenue:

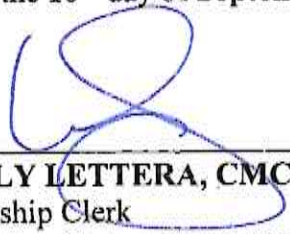
Outside CAP – State & Federal Grants

\$2,036.00 from the National Wildlife Refuge Fund (Revenue Sharing) FY 2026 payments for 2025
