

**RESOLUTION 2026-255**

**RESOLUTION OF THE TOWNSHIP OF LITTLE EGG  
HARBOR, COUNTY OF OCEAN, STATE OF NEW  
JERSEY, AUTHORIZING THE TAX COLLECTOR TO  
CANCEL TAXES AND PROVIDE A REFUND PURSUANT  
TO N.J.S.A. 54:4-3.30 ON PROPERTY QUALIFYING FOR  
VETERANS PROPERTY TAX EMEMPTION  
(AMANDALYNN YOUNG, BLOCK 325.74, LOT 5)**

**WHEREAS, N.J.S.A. 54:4-3.30** provides for an exemption from property taxes on certain property owned by a totally-disabled Veteran; and

**WHEREAS,** it has been determined by the Tax Assessor that property known as Block 325.74, Lot 5, owned by Amandalynn Young and Rose Ford, qualified for a Veterans' Property Tax Exemption in the year 2026; and

**WHEREAS,** the determination by the Tax Assessor is the result of an assignment of a 100% permanent and total wartime service-connected disability evaluation from the Veterans' Administration; and

**WHEREAS,** the Tax Collector has requested authorization to cancel property taxes, in the amount of \$3,108.81; and

**WHEREAS,** pursuant to N.J.S.A. 54:4-3.32 the Township Committee has the authority to cancel charges for a totally-disabled veterans portion of the 2026 taxes when a N.J.S.A. 54:4-3.30 Certification of Assessment Credit for Exemption has been granted; and

**WHEREAS,** the Tax Collector deems that the Title Company, Kingdom Title, LLC, receive a refund on taxes already paid for the year 2026 in the amount of \$1,382.89; and

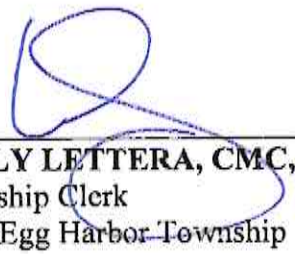
**NOW, THEREFORE, BE IT RESOLVED,** by the governing body of the Township of Little Egg Harbor, County of Ocean, State of New Jersey as follows:

1. That the Mayor and Township Committee do hereby authorize the Tax Collector to cancel property taxes in the amount of \$3,108.81, for the year 2026 for Block 325.74, Lot 5, owned by Amandalynn Young and Rose Ford and authorize a refund to Kingdom Title, LLC, in the amount of \$1,382.89.

2. That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Tax Collector, the Tax Assessor, Amandalynn Young, Kingdom Title and the Chief Financial Officer.

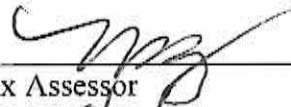

**TOTALLY DISABLED VETERAN**  
**ASSESSMENT CREDIT WORKSHEET**

WHEREAS, N.J.S.A. 54:4-3.30 provides for an exemption from taxes on certain property owned by a totally-disabled veteran; and

WHEREAS, it has been determined by the Tax Assessor that the property known as Block 325.74 Lot 5 owned by Young, Amandalynn qualifies for a Veteran's Property Tax Exemption as of July 9, 2026.

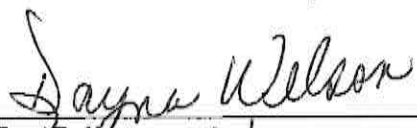

WHEREAS, the Tax Collector has requested authorization to cancel property taxes for 2026 based upon a prorated assessment of \$190,500 applied by the F02 Tax Rate, taxes outstanding that would otherwise be exempt.
